Report RE: Supplemental Final Disposition: Case Closure by Non-Prosecution

Details:

On December 16, 2019, Nevada Department of Public Safety, Investigation Division, (NV DPS ID) Major Crimes Unit Det. D. Earl received an e-mail from the Washoe County District Attorney's Office (WCDAO), with an attached letter (PDF) signed by WCDAO Chief Deputy District Attorney Matthew Lee. This letter was addressed to County District Attorney, Anne Langer. Det. Earl reviewed the letter and noted the following:

Mr. Lee advised Ms. Langer he reviewed the investigative materials she presented to his office and decided not to prosecute L. based upon insufficient evidence to support a conviction for NRS 199.120, NRS 199.245, and NRS 239.330. Furthermore, since NRS 281.050 does not involve criminal sanctions, Mr. Lee gave no opinion as to the validity of 'S actions as they relate thereto.

The letter from WCDA Lee is attached to this case closure report.

There are no other defendants in this case.

Det. Earl requests this case be closed due to the fact the State of Nevada Attorney General's Office, the County District Attorney Office, the County District Attorney's Office, and the County District Attorney's Office, all declined to prosecute L.

DISPOSITION OF EVIDENCE:

The evidence in this case was reviewed and a copy of the remaining evidence (File On-Q) is attached to this case report.

Evidence Item: Pkg #1 (barcode #188312) is a USB storage device containing Evidence Items DE-1 through DE-9; which contains documents, deposition paperwork, digital recordings, e-mail correspondence and maps. Det. Earl completed an Evidence Destruction Memorandum and submitted it to the County District Attorney's Office regarding the evidence in this case. On December 18, 2019, Det. Earl received an e-mail from WCDDA M. Lee with the signed Case Closure / Evidence Release/ Destruction Form attached. WCDDA M. Lee advised the evidence in this case could be destroyed or retained by the Investigation Division in accordance to policy.
