County PENDING MATTER

Assistant District Attorney Bruce Hahn:

Our office is seeking assistance from you in the review and potential prosecution of the abovereferenced matter as there is a conflict of interest wherein the alleged defendant is an elected official, an acting commissioner in County, who this office represents due to his position in the County.

Following review of the investigation received from the Storey County Sheriff's office, it was determined that further investigation was needed, and on June 28, 2018, the case was re-submitted to the Storey County Sheriff's office.

On or about July 20, 2018, both the Storey County Sheriff's office and our office presented the case to the Nevada Department of Public Safety Investigation Division (NDI), requesting an investigation.

Once NDI completed their investigation, a report dated April 23, 2019, was presented to both the Storey County Sheriff's office as well as the Attorney General's office.

On May 10, 2019, Michael Kovac, Chief Deputy Attorney General responded to Detective Earl of NDI that because the case involved a county officer or employee, the local district attorney has primary jurisdiction and that the Office of the Attorney General would be taking no further action. Detective Earl then forwarded the full report and case findings pursuant to their investigation on or about May 16, 2019, to our office for review.

Following further review of the original investigation along with NDI's investigation by our office, it was determined that review from a surrounding county District Attorney's office was warranted. The report and case findings was then forwarded to Stephen B. Rye, Lyon County District Attorney on August 15, 2019. Following the receipt of the file, Lyon County returned the case to our office on September 10, 2019, stating they did not have the staffing to review the matter at this time.

Subsequent to Lyon County returning the file to our office on September 24, 2019, I contacted Christine Brady, Second Assistant Attorney General, and requested a review of the file since I have a conflict. I was told by Ms. Brady that she knew about the file because NDI had originally sent the file to them earlier in the year for review. See Michael Kovac's statement above. Since Ms. Brady had already seen the file she believes that Washoe County also has jurisdiction to prosecute this case and determined that the file should be sent to Washoe County instead of the Attorney General's office at this time. Thus, I am hoping for your assistance in reviewing this file and advising me on whether your office will take this case.
