Meeting was called to order by Chairman Carmona at 10:00 A.M.

#### 1. PLEDGE OF ALLEGIANCE

Commissioner Carmona led those present in the Pledge of Allegiance.

**2. DISCUSSION/POSSIBLE ACTION:** Approval of Agenda for February 2, 2021. County Manager Osborne requested Item 13 be continued.

#### **Public Comment:**

Storey County resident, Nicole Barde: Number 13 is Resolution 602, correct? Ms. Barde suggests that the paperwork in that packet be reviewed - why is it even on the agenda? The Resolution states that it has already been passed with all of the "ayes" Carmona, Mitchell, and Gilman and looks as if this has already been decided. Why would it be put on an agenda when already decided? How could it have already been decided when is has to come before the public? Look at page 3 and 4.

Mr. Osborne: This item is for approval of the agenda - he will respond when we get to Item 13.

Motion: I, Commissioner Mitchell, move to approve today's Agenda for February 2, 2021 -

- 6. PUBLIC COMMENT (No Action): None
- 7. DISCUSSION ONLY (No Action): Updates and discussion from county lobbyists and staff regarding upcoming bills and legislative actions potentially effecting Storey County.

County lobbyist Mary Walker: Legislature began yesterday - it is early in the process. A couple of bills to bring to attention:

BDR 579 - submitted by Senator Settlemeyer on behalf of the County in regard to Storey
County joining the Carson Water Subconservancy District (CWSD). This will allow Storey
County to be a full member and pay dues to the District through the existing general fund - so
there is no tax impact.

Lobbyist Steve Walker: The request by CWSD also asks that Alpine County be included in this legislation. Alpine County is in California - one state cannot dictate what another state is going to do. The Bill will not include Alpine County. In order to put Alpine County into the Subconservancy District, the California State Legislature would have to pass the same bill as the Nevada Legislature. The Alpine County representation in the Carson Water Subconservancy District is there - although not formalized. And it should be as it is the "top of the watershed" county.

Ms. Walker explained this bill is still being drafted. As soon as there is a draft, it will be sent to Mr. Osborne, and team, to make sure the wording is correct. It should be introduced some time in March.

- FC 67 Clark County Public Works bill: Allows governments to do more public works
  projects "in-house" if they choose to do so. Currently if a project is more than \$100,000 it has
  to go out to bid. This will change to \$250,000 with this bill. (The County) would be able to do
  more projects "in-house". How a contractor is chosen for projects would not be based on lowbid, but on qualification.
- Innovation zones are one of the Governor's top initiatives. A bill has not yet been submitted but it is coming then it will be submitted to County staff for review ASAP.

Steve Walker reviewed Water Bills AB 5 an AB 6 - mostly "housekeeping bills".

- AB5 Judicial review only after a decision has been made by the State Engineer.
- AB6 Discretionary to hold a hearing on temporary changes. And to hold a hearing when a conflict exists with an existing right.

Mr. Walker explained other proposals addressing the issue of how to convert agricultural water rights to municipal/industrial water rights more efficiently and to be more available. One is the "Conservation Bill". Another is a "water bank" converting water from agricultural use to the "bank" for other uses. These are not Bills yet - but basically address the issues that need to move forward. SJR1 creates a "Water Appeals Court" - the word is this will be pulled. This is based on the fact SJR1 addresses the District Court making water decisions, and the District Court Judge and staff, do not have the background for that. When the conservation and water banking bills are refined, and out to everyone, maybe they can move forward.

Ms. Walker: At this point about 170 bills have been introduced and have been sent to County staff for review. At least 90% of the Bills are mostly "operational-type" - public works, etc. About 10% will be policy bills which need to come before (this Commission) for direction.

## 8. DISCUSSION ONLY (No Action - No Public Comment): Committee/Staff Reports Fire Chief Loncar:

- In the final days of negotiation with NVEnergy to obtain more funding for fuel removal.
- Moving forward in finding a new EMS Director. The current Director's contract expires at the end of February he will not be renewing.
- One paramedic is currently working at a hospital in Ventura. This is great experience for him.
- A District survey has been submitted to all staff for input on where they see the future things
  they would like changed a platform to express opinions. The surveys will not be available to
  anyone else, but will be available to any Commissioner is interested in seeing them.

Chairman Carmona said he would like to see the surveys.

#### Jason Wiezrbicki, Public Works Director:

• A lot of hours were invested in keeping the town and Highlands clear after last week's storm. Snow is still being hauled to make room.

Chairman Carmona asked if NDOT has full control of snow removal on C Street or, does (Public Works) assist in that? Do they normally bring out a loader to clear some of it out? There have questions regarding parking.

Mr. Wiezrbicki: NDOT has taken care of it this year - they have not asked for assistance. They use a loader, dumping into dump trucks.

Vice Chairman Mitchell: How did we do in other areas of the County? He assumes we weren't hit as hard as the Highlands.

Mr. Wiezrbicki: There were a few inches in the industrial park. There were a couple guys there around the clock. The majority was in Virginia City and the Highlands.

#### Mike Northan, Project Manager:

- 1) Justice Court/Divide Building is at substantial completion:
  - Contractor is working through the final punch-list. The building has nice functional, modern hardware and infrastructure. All safety systems are in-place and operational.
  - They have the Certificate of Occupancy.
  - Some items need to be completed before operations can begin including an audio/visual system.
  - Furniture and equipment will be delivered in mid-March.
- 2) Communications Tower on Parkway:
  - Bids for conduit installation will be presented at the next Board meeting.
- 3) Highlands Fire Station:
  - Design proposal received from Lumos & Associates for the fire engine storage building and is currently be evaluated. The building will house additional equipment being acquired by the Fire District.
- 4) Visitors Center:
  - Design proposal for the new Visitors Center has been received from Lumos & Associates.
  - A meeting is being held today with another design firm keeping the County's options open for the best pricing and design.

Chairman Carmona: Is there an ETA date for construction or completion of the Highlands Community Center?

Mr. Northern explained this will be done in two phases. The storage building has to be in place before opening up the existing metal building for remodel. He would like to see construction start on that (storage) building so he can give an actual timeline on the "meeting" building.

- Three employees are going to be Certified Trainers. This will build-up their training program.
- Mid-April is the date for moving into the new dispatch center.

#### Joe Curtis, Emergency Management Director:

- The County is at 71 cases for almost three weeks 55 recovered, 2 deaths. It is difficult to verify active cases as people do not respond to phone calls, etc.
- The County is doing a good job with a positivity rate of virtually zero.
- Total cases for the Quad-Counties: 10,786; active 3,320; recovered 7,270. 190 deaths.
- Community testing and approximately 300 vaccinations for age 70 and over, as well as second doses, were done yesterday.
- Wednesday, February 10th Covid testing only will be done.
- Thursday, February 11<sup>th</sup> Vaccinations for 70+, by appointment only. If all appointments are filled, we may go on Friday the 12<sup>th</sup>.
- The next vaccination date will be February 24<sup>th</sup> for 2<sup>nd</sup> doses for people who got vaccinations on February 11<sup>th</sup>. By appointment only.
- Thanks to the Sheriff's office and the Fire Department for their participation being on-site at the vaccination location. This is a requirement by the State for vaccination clinics.
- The Sheriff's Cert team, along with the Jeep Posse, are there for traffic control. This could not be done without them. There is also an ambulance provided by the Fire Department on standby, which has not been needed so far.
- So far, there will be three vaccination dates in February. If all appointments are filled for the 11<sup>th</sup>, a second will be held the next day through Safeway Pharmacy group.
- Call Storey County Senior Center or Community Chest for appointments (you must be 70 years of age or older at this time).
- There is no information about when the next (age) category will open up.
- Mr. Curtis reviewed the steps when getting a vaccination. After the vaccination, people are required to sit in a chair for 15 minutes to insure they are okay.

Vice Chairman Mitchell thanked Joe for all of his help around town - digging people out, and also with the vaccination process.

#### Deny Dotson, Tourism Director:

- C Street will be closed tomorrow morning from Taylor to Union. Crews will be here filming women who work, or own businesses, in Virginia City highlighting the history of women who worked and currently work here.
- Staff continues to work on budget. It is an interesting year to budget, not knowing what lies ahead.
- Events are limited in what can be done right now. Big events will not be announced until really close.
- Two events being worked on:
  - o "The Devil Made Me do It" will be a day in Virginia City in collaboration with hotels and restaurants taking their occupancy limits and selling as packages. This is sold out.
  - o The Rocky Mountain Oyster Fry will be "streamed down" (being much smaller) and spread out. It will move forward as long as we stay within guidelines.
- Pipers Opera House:
  - o Staff is working on country line dancing and monthly game night (bingo).
  - o Also, a murder/mystery play for the spring.
  - o Starting to have some activities staying within current guidelines. We would also like to see things open a bit it would certainly help. Pipers had a tough year last year and

will be in the red. They have done everything they can to cut expenses - it is difficult when you can't have more than 25% (occupancy).

#### Austin Osborne, on behalf of Mike Nevin, Water/Sewer Project Manager:

• The water tanks project is moving along just fine. The sewer construction project is also moving right along.

#### Kathy Canfield, Senior Planner:

• Tonogold is conducting a series of exploration activity - mostly in the Divide area and Gold Hill. This is permitted with the (activity) closest to town having limitations on being in and out in 10 days. They are working Monday thru Friday, 8 to 5.

#### James Deane, Storey County IT Director:

- Half of the equipment has arrived for archiving all Storey County data.
- Almost ready to launch the public records request portal on the website. This will allow people to directly interact with the County on a database system.

#### Stacy York, Virginia City Senior Center:

- About 150 appointments have been scheduled for vaccinations on February 11<sup>th</sup> age 70 and over, Storey County residents only.
- For Lockwood residents who need transportation up the hill, the Senior Center has a transportation program.
- The Senior Center has a waiting list for Quad-County residents, with about 200 people on that list. As soon as appointments open up, they will get everyone scheduled.

Vice Chairman Mitchell: Is the waiting list for Quad-County for people who are not residents of Storey County, or those who are not in the group that has opened up yet - or a combination of both?

Ms. York: Combination of both. There are about 10 waiting lists. Some include Quad-Counties, some are 60-65, some under 60, as well as other lists. They are slammed with vaccine appointments.

Chairman Carmona and Vice Chairman Mitchell thanked Ms. York.

#### St. Mary's Art Center Executive Director Arika Perry:

- Working on the 2021 calendar looking at programming and what can be done this year.
- Hopefully, they can hold the "imagination children's art program", classes, art & crafts programs, etc.
- They are looking at various exhibitions and events all tied to what is allowed under Covid.
- The first community event up for discussion, is the Easter Egg Hunt on the lawn. They do not know if this will be an option this year or not.
- They have been working on significant improvements, restoration, and maintenance.
   Including renovating some of the bathrooms, structural failures, plumbing fixtures, among others.
- Paperwork is ready to be submitted for the Commission for Cultural Centers and Historical Preservation Grant. \$100,000 was received from them to address the front porch and main entrance that is not pitched creating a slope for drainage. Also, restoration of the front room and façade on the front of the building and repointing the brick. The majority (of the work)

- will be focused on this summer when closed in July to accommodate the County/SHPO collaboration for work being done by interns who will be staying there.
- They are focusing on other projects in the meantime including re-building the back stairwell which has been closed off for a long time. This will help improve traffic and social distancing during the pandemic.

#### County Manager Austin Osborne:

- Capital Improvement Projects being worked on for the next coming year:
  - o Lockwood Tower Road easement mapping and surveying is being done.
  - o Lockwood Senior Center upgrade/commercial kitchen, and other improvements. Discussion is on-going. Public workshops will be held in warmer weather.
  - o Reasonable improvements to the Sheriff's sub-station in Lockwood clean-up, some upgrades, and parking.
  - Highlands Fire Station previously discussed.
  - o Mark Twain and Lockwood flood programs both depend on (the County's) Carson Water Subconservancy District membership. As well as working with Truckee River Flood Management - two big projects that may exceed millions of dollars. Grant funds will be sought from FEMA and other sources.
  - VC Freight Depot work is being done to get sprinklers installed.
  - o Fairground road is in escrow to purchase the "apron" for access to the fairgrounds.
  - o USGS Water Study in the Highlands goes on. A 4th year update will be coming soon.
  - o The comprehensive, south and central Storey County Water Master Plan is moving forward. Drafts will be ready shortly for public review.
  - o The Franchise Agreement with Waste Management provides for six (no charge) illegal dump site clean-ups. If anyone in the County sees anything, send pictures and we will have it taken care of.
  - Work continues on the Lands Bill affecting some homeowners in Mark Twain.
     Congressman Amodei's office is taking the lead on this Senator Cortez-Masto's office is also involved in moving this forward.

#### 9. BOARD COMMENT (No Action - No Public Comment)

#### Vice Chairman Mitchell:

 Appreciates the community pulling together especially with the recent weather. Neighbors helping neighbors - it means a lot. Thank you.

#### Chairman Carmona:

- Stinke a fixture on the boardwalk for years, has some medical issues. For those interested in getting a message to him, his daughter is on Facebook. Search the VC page for a post.
- 10. DISCUSSION ONLY: Presentation by Lisa K. Taylor, Ph.D., Assistant Professor and Extension Educator University of Nevada Reno, College of Agriculture, Biotechnology, and Natural Resources Carson City/Storey County Extension summarizing the results of UNR's Extension Program Needs Assessment.

Lisa K. Taylor presented UNR's Extension Program Needs Assessment. There were 150 local participants for the survey. Stakeholders helped with the questions - business leaders, the Community Chest and Library, as well as resource managers - from across Storey County. The

purpose of the survey was to engage the community and stakeholders to drive programs and activities for the future.

Ms. Taylor reviewed the questionnaire that was sent out and how the Assessment was promoted, including through social media. 28 interviews were conducted. She gave a breakdown of age, race, and gender of the individuals that participated. The Assessment was focused on agriculture, community development, health and nutrition, horticulture, natural resources, and personal and family development. The survey looked at 11 different options.

Ms. Taylor reviewed the survey results. Health and nutrition was a primary area discussed by County participants. Another area was natural resources - including how to preserve green, open spaces. Ms. Taylor discussed several training areas. Results talked about community assets that should be optimized and/or supported - and services that are available. The survey shows the growing population will be reliant upon community resources. Responses suggested infrastructure that is needed- such as roads, park management, and other critical services, and the monetary support. Also mentioned, the need to offer educational opportunities, and quality of life for infants and older adults in programs and activities. As well as, focus on gardening and other natural resource management activities.

Ms. Taylor presented the "priorities based on findings". This includes youth programming, 4-H, and after school education, programs for seniors, gardening programs - among other programs. Wildfire prevention was mentioned as one of the most critical (programs).

Ms. Taylor discussed programs being conducted through UNR's Extension Program. Programs are being presented virtually. The program offering radon test kits continues. This year "home child care provider" training will be offered.

Ms. Taylor thanked the Board for the opportunity to present the survey results.

Vice Chairman Mitchell asked about the assessment - is it periodic, is there a specific impetus, or is it primarily to guide activities of the Extension?

Ms. Taylor said it has not been conducted in over 12 years. Normally it's between 5 and 8 years - and it will not be put on a shelf. She explained these findings are for the community and they will be working to share with all (the County's) organizations. The information could be advantageous for them.

Vice Chairman Mitchell suggested they could add the Mark Twain Community Center as a location for radon test kits to get them out in the community. He can get her in touch with the Board.

Chairman Carmona thanked Ms. Taylor for the update.

11. DISCUSSION/POSSIBLE ACTION: Consideration and possible action regarding inmate food service vendor for the remainder of 20/21 and into 21/22.

Sheriff Antinoro: There has been a struggle for years to provide meals for inmates meeting all nutritional requirements. An out-of-state vendor provided meals but the shipping was more than the

product. A local provider "went by the way-side". They have been providing "Hungry Man" dinners. Each year, they reach out to local providers to see if there was interest. Bids (to provide meals) were received from the Senior Center and The Roasting House. They were given the nutrition criteria that is required. Either one would do an exceptional job. The Roasting House came in 70 cents less per inmate, per day.

Sheriff Antinoro recommended awarding a contract to The Roasting House for fiscal year 2022, beginning July 1 through June 30. However, he would like to start as soon as (The Roasting House) is up for it. They want to get away from the Hungry Man meals as quickly as they can.

Public Comment: None

Commissioner Gilman: The Sheriff has done more than adequate research of the opportunities. He agrees with the importance of supporting the local community.

Vice Chairman Mitchell: Agrees. This is an excellent opportunity to reinvest taxpayer dollars back into the private sector and is pleased there is a local option to meet the requirements.

Chairman Carmona: Agrees with the other Commissioners.

Motion: I, Commissioner Mitchell, move to approve the Roasting House as the inmate food service vendor for the remainder of the 2021 fiscal year, and continuing in to the 2021-22 fiscal year, Action: Approve, Moved by: Vice Chairman Mitchell, Seconded by: Commissioner Gilman, Vote: Motion carried by unanimous vote, (Summary: Yes=3)

12. DISCUSSION/POSSIBLE ACTION: Consideration and possible approval Resolution 21-601 providing for in-county general, liquor, cabaret, brothel, and gaming business license fee reimbursement generally equivalent to the amount paid for two quarters of fees by businesses principally impacted by use restriction or closures due to the COVID-19 pandemic and related Declaration of Emergency Directives issued by the Governor. This is the second of two hearings on this resolution.

Commissioner Gilman recused himself from discussion and vote on this item.

County Manager Osborne: A summary of this item was presented at the last Commission meeting. This is Covid recovery for small County businesses - providing an equivalent, or near, 50% reimbursement for business licenses for all business types.

Public Comment: None

Vice Chairman Mitchell: If there are things we can do to reduce tax burden/fees on the local businesses - it's the right move.

Vice Chairman Mitchell stated that for transparency, he is a small business owner - but his business is mobile and substantially outside of the County, with licensing with the State or other jurisdictions.

He would not be affected directly in a financial way from this decision. He believes this is the right direction to go and is comfortable the fiscal impact would not hurt the County's operations or services.

Chairman Carmona: This is good - it will not solve everyone's problems - it's a way to help local businesses during this historic time.

Motion: I, Commissioner Mitchell, move to approve Resolution 21-601 providing for in-county general, liquor, cabaret, brothel, and gaming business license fee reimbursement generally equivalent to the amount paid for two quarters of fees by businesses principally impacted by use restriction or closures due to the COVID-19 pandemic and related Declaration of Emergency Directives issued by the Governor, Action: Approve, Moved by: Vice Chairman Mitchell, Seconded by: Chairman Carmona, Vote: Motion carried by unanimous vote, (Summary: Yes=2)

13. DISCUSSION/POSSIBLE ACTION: Consideration and possible approval of Resolution No. 21-602 expressing impacts on businesses by certain State COVID-19 mitigation restrictions, the need and right for equitable treatments for all businesses, and the honor to protect the health, safety, and wellbeing of residents and visitors in Storey County.

Continued to a later date.

#### 14. RECESS TO CONVENE AS THE STOREY COUNTY FIRE PROTECTION DISTRICT

15. DISCUSSION/POSSIBLE ACTION: Consideration and possible approval of disposal by means of auction, donation, sale or trade in of surplus District fire apparatus and vehicles.

Fire Chief Jeremy Loncar said there is currently five pieces in various states of disarray and usage. Some have a lot of age and miles, some used as parts vehicles. To thin down the fleet, some are better sent to a scrap yard, others to auction. There is an offer for a trade-in which would help with the ambulance currently being built. He also would like to keep auction available to donate equipment that is no longer useful for the County but could help neighboring smaller agencies.

Public Comment: None

Sheriff Antinoro asked if this would help get rid of some of the stuff being stored by the detention center.

Chief Loncar: Yes. Some will be left but for the most part he wants to clean up what's there.

Commissioner Gilman: Thinks this is a great idea and loves the idea of sharing with some of the communities that do not have the equipment - he is 100% supportive of this plan.

Motion: I, Commissioner Clay Mitchell, move to approve the disposal of the five surplus Fire District apparatus and vehicles listed in the staff summary by means of auction, donation, sale, or trade in, Action: Approve, Moved by: Vice Chairman Mitchell, Seconded by: Commissioner Gilman, Vote: Motion carried by unanimous vote, (Summary: Yes=3)

## 16. RECESS TO CONVENE AS THE STOREY COUNTY BOARD OF COUNTY COMMISSIONERS

17. DISCUSSION/POSSIBLE ACTION: Consideration and possible approval of Second Reading of Bill 125, Ordinance 20-314, Text amendments to Storey County Code Title 17 Zoning Districts E Estate; F Forestry; and NR Natural Resources which include modifications and clarifications regarding the minimum floor area. Text amendments to the P Public Zone for modification and clarification of setbacks, and other properly related matters.

Kathy Canfield, Senior Planner, explained these are Code amendments related to residence sizes for Estate, Forestry, and Natural Resources zones. This also modifies Public Zone setbacks. The first reading was approved and no comments received. Staff and the Planning Commission recommend approval.

Public Comment: None

Ms. Canfield read the title:

This is the second reading of Bill 125, Ordinance 20-314, an Ordinance amending Storey County Code Title 17, to establish the minimum square footage for residences in the Estate, Natural Resources, and Forestry zones, and modifying setback requirements in the Public Zone, and providing for other matters properly related thereto.

Motion: In accordance to the recommendation by staff and the Planning Commission, I, Commissioner Mitchell, move to approve the Second Reading of Bill 125, Ordinance 20-314, Text amendments to Storey County Code Title 17 Zoning Districts E Estate; F Forestry; and NR Natural Resources which include modifications and clarifications regarding the minimum floor area. Text amendments to the P Public Zone for modification and clarification of setbacks, and other properly related matters, Action: Approve, Moved by: Vice Chairman Mitchell, Seconded by: Commissioner Gilman, Vote: Motion carried by unanimous vote, (Summary: Yes=3)

18. DISCUSSION/POSSIBLE ACTION: Consideration and approval of purchase of Vaddio Soft Conference system from Justice AV Solutions, Inc. The Vaddio system would be an upgrade to the current audio/visual system in the District Courtroom allowing for the integration of Zoom. Total purchase price not to exceed \$5,409.71.

Clerk Vanessa Stephens explained that JAVS, the current audio/visual system used in the Courtroom, has a software system called Vaddio which integrates with Zoom. This allows cameras and microphones already in place in the Courtroom to be used. This can be used by the Commission, the Planning Commission, and the District Court.

Public Comment: None

Commissioner Gilman: We're in the "world of zoom" - no one can tell how long that will be. The upgrade of \$5,400, is worth the investment.

Vice Chairman Mitchell: Checked the prices of the components and found them to be in-line. As he understands, this will pave the way to stream meetings on-going. This will allow people in other

areas of the County to have easier access to participate in public meetings and process. He is in support of this.

Chairman Carmona: Feels the same way. When Covid goes away, this will be how business is handled going forward - it is a worthwhile investment. Folk are used to logging-on to meetings without the need to drive here. We're moving in the right direction.

**Motion:** I, Commissioner Mitchell, move to approve the purchase of the Vaddio Soft Conference system for use in the District Courtroom. Total purchase price not to exceed \$5,409.71 -

Vice Chair Mitchell asked if this was totally County-funded. Ms. Stephens responded that it is fully out of the County budget, the District Court and Clerk will split the cost.





#### Governor Sisolak:

The Board of Storey County Commissioners on March 2, 2021, directed county staff and lobbyists to take certain positions on BDR 1109-related draft legislation providing for the creation of Innovation Zones. Storey County opposes the Innovation Zone bill as presented thus far; however, the board finds merit in certain elements of the bill including expanding technology uses across the county and developing a mixed-use residential community at Painted Rock. The following summarize the board's directives.

1. Technology – Support and work with legislature and applicable elected officials to explore Blockchain, cryptocurrency, stable-coin, and other such technological advances and currency.

Storey County is Nevada's forerunner in embracing and utilizing new technologies, and the board finds that new digital platforms such as stable-coin and Blockchain to be the potential digital capital of the future. We will seek guidance from the Nevada Department of Taxation; county recorders, clerks, and treasurers; and other such agencies and associations to evaluate the viability of these technologies and develop appropriate framework for their implementation.

2. Residential "Smart City" - Continue to support 2016 Storey County Master Plan as applicable to neotraditional and new-urbanistic design as proposed by Blockchains' "Smart-City".

The Storey County Master Plan supports large-scale residential development at Painted Rock. A mixed-use community integrating commercial, residential, and live-work use patterns is preferred over suburban "sprawl". Graphic renditions by Blockchains, LLC and R&R Partners illustrating high-rise buildings clad in stainless-steel and glass, situated within clustered high-density nodes, and supported by multi-modal transit and "Smart" infrastructure are aligned with the goals and objectives of the plan for this area.

3. Separate Local Government – Oppose separatist governing control and carving up Storey County.

Carving out a separate government within Storey County is not necessary for the advancement of technology, innovative industries, or residential "smart city" development. Storey County has for 20 years been Nevada's leader in attracting, permitting, and supporting technology, manufacturing, and energy sectors, and transforming northern Nevada from dependence on gaming to the diversified economic powerhouse it is today. Tesla, Panasonic, Switch, Google, Fulcrum Bioenergy, and nearly 20 million square-feet of other companies made Storey County their home because of fast and simple permitting, easy access to elected and appointed officials, and a dedicated team capable of finding innovative ways to overcome economic, social, environmental, and geographic obstacles.

Removing Storey County from the proven calculus it formulated may cause adverse economic, social, and environmental impacts to the county and region. We will explore ways in which objectives in the draft legislation may be achieved within existing local and state regulatory framework.

4. Planning & Development – Reach out to Governor, Blockchains, and others for meaningful and authentic good-faith discussion to coordinate planning and oversight within existing governing framework.

Conversations about the proposed legislation must consider state and local regulations, and binding agreements in-place in Storey County such as the Tahoe-Reno Industrial Center (TRI-Center) development agreement, TRI-Center infrastructure payback agreement, the TRI General Improvement District regulations and responsibilities, the inter-county effluent water line Tax Increment Area agreement, economic development and diversification districts for technology and manufacturing sector abatements, court degrees, utility and other easements and rights-of-ways, and government services agreements.

5. Progress - Periodically update the Storey County Board of County Commissioners on the status of Innovative Zone BDR and bill, to and seek amended direction as conditions change and are known.

We will periodically update the board on research findings into the Innovation Zone matters and seek direction as conditions change and more is known about the draft bill.

We respectfully request a meeting with you and your team to openly discuss the Innovation Zone bill. We look forward to being part of a conversation about the potential benefits in the draft bill, and ways to overcome challenging aspects of the proposed legislation within existing fiscal, economic, environmental, and land use regulatory structures.

A Planning Commissioner is like a judge who renders decisions based on the testimony of experts and others who appear as witnesses in a trial. Minimum qualifications of a Planning Commissioner include: a willingness and ability to research and report on issues, programs, and policies related to local land-use matters; ability to attend afternoon and night meetings on a regular basis; ability to sustain harmonious working relationships with commission members, the Board of County Commissioners, staff, residents, applicants, and the public; ability to act within the ethical standards set forth by NRS and NAC; and willingness to expand knowledge related to land-use planning. The new-appointee must successfully pass a criminal background investigation.

- Staff Summary: Sales tax and property tax generated by Tesla are fully abated between 2014 and 2024. A Government Services Agreement (GSA) between Storey County, the Storey County Fire Protection District, and Tesla was executed in 2014 to offset fiscal impacts that the Gigafactory may cause to the county and fire district. Section 5 of the GSA states that in 2018 the parties may revisit certain elements of the agreement to make necessary adjustments based on actual costs at that time.
