Staff summary

Per NRS 245.170 the board of county commissioners shall appoint a suitable person who is an elector of the county to fill the vacancy for the remainder of the unexpired term. Clerk-Treasurer Nevin, the current Storey County Clerk-Treasurer, submitted a letter of resignation to be effective 09/16/22 and before her elected term expired. The board acknowledged the resignation at its 08/16/22 meeting. The board was required to appoint an interim Clerk-Treasurer to fill the vacancy for the remainder of the term. There remains approximately four months left of that term. Jim Hindle won the primary election for Storey County Clerk-Treasurer, and he is now uncontested and the only general election candidate remaining on the ballot for that office. Therefore, the board found it appropriate to appoint him to fill the vacancy until such time that he automatically assumes the permanent role in that office. On 08/31/22 Clerk-Treasurer Nevin informed the County Manager and others via the attached statement that she intends to resign effective 09/09/22 instead of 09/16/22. The board will need to acknowledge this amended date and appoint an interim Clerk-Treasurer to fill the remainder of the term. Staff recommends that the board take similar action as it did on 08/16/22 with the amended start date.
